Issue of Placement shares

Core Exploration Limited (ASX: CXO) is pleased to announce that has issued 43,511,385 fully paid ordinary shares as announced on 18 February 2016. The Company has issued the Shares to sophisticated, professional and institutional investors under a share placement raising \$957,250 (before costs).

Disclosure required under ASX Listing Rules 7.1A.4(b) and 3.10.5A

In relation to the Placement, and in accordance with ASX Listing Rules 7.1A.4(b) and 3.10.5A the Company makes the following disclosures:

- (a) The Company has issued a total of 43,511,385 fully paid ordinary shares at 2.2 cents per share. Of the securities issued, 17,467,679 fully paid ordinary shares were issued under Listing Rule 7.1A and the remaining 26,043,706 shares were issued under the Company's 15% placement capacity under Listing Rule 7.1.

The securities issued under Listing Rule 7.1A result in the following dilution to existing holders of ordinary securities:

- Number of fully paid ordinary shares on issue prior to the placement of securities under LR 7.1A was 174,831,483.
- Number of fully paid ordinary shares on issue following this issue of securities under LR 7.1A will be 192,299,162 (a total of 218,342,868 including the issue under LR 7.1).
- Percentage of voting dilution following the issue under LR 7.1A is 10% (25% whereby the issue of shares under LR 7.1 is taken into account).

- (b) The Company will issue shares as a placement to sophisticated, professional and institutional investors. The issue will be made as a placement and not as a pro-rata issue or other type of issue in which existing shareholders would have been able to participate. This approach has been taken as it considered that the issue, being carried out as part of the Placement, is the most cost-efficient and expedient method available at the time for raising, at an appropriate price, the funds required by the Company to achieve its objectives, given the funding certainty, strong investor enquiry and the pricing achieved under the Placement. Additionally, the



Company completed a rights issue in November 2015 giving all shareholders the opportunity to participate in the Company's equity issue.

- (c) No underwriting arrangements were entered into in relation to the placement under Listing Rule 7.1A.
- (d) Fees of 6% of the total funds raised under the Placement are due to be paid. In addition to the fees paid under the Placement, Hartleys will be issued 10,000,000 quoted options exercisable at 5 cents each by 31 August 2017 (CXOOA) subject to approval by Core shareholders at a general meeting to be held following the placement.
